About CRS

Catholic Relief Services is the official international humanitarian agency of the Catholic community in the United States. CRS works to *save, protect, and transform* lives in need in more than 100 countries, without regard to race, religion or nationality. CRS' relief and development work are accomplished through programs of emergency response, HIV, health, agriculture, education, microfinance and peacebuilding.

The CRS Egypt country program began in 1956 at the invitation of the Egyptian president Nasser by providing relief assistance to the victims of the Suez War. Over the following few decades, CRS Egypt moved from large-scale food relief to long-term poverty alleviation and development programs. CRS Egypt works in a wide variety of areas within the development field.

Currently, CRS Egypt has three main programs: the Education Assistance program, the Livelihoods Program for refugee support, and local partnerships. Projects under these programs range from the provision of technical assistance and capacity building to partners, promoting peace and tolerance, educational grants for refugees and assistance to refugee community schools, and technical support and start-up funds for refugee and vulnerable Egyptian entrepreneurs. Additional programming includes Emergency Preparedness and Response projects that arise as needed. The Operations department, supported by a regional Management Quality unit, ensures the country program develops and maintains the highest level of operational standards.

CRS currently supports programs in the sectors of humanitarian relief, livelihoods, civil society strengthening, and social justice promotion through its CRS Egypt currently holds a main office in Cairo and a field office in Maadi.

Job Summary:

The logistics officer will oversee the execution of daily logistics operations linked to Fleet ,Warehouse and Convoy management, ensuring timely provision of goods and services essential for the smooth functioning of programs. Leveraging your expertise, you will manage logistical requirements and address challenges, while upholding principles of stewardship, integrity, transparency, and accountability.

The Logistics Officer is responsible for the meticulous processing, systematic organizing, and secure storage of inventories in CRS-designated facilities. This role is crucial in ensuring that all shipments strictly adhere to organizational standards, which is essential for maintaining the integrity and efficiency of our logistical operations. The Logistics Officer plays a pivotal role in upholding these standards across all stages of the supply chain, ensuring seamless coordination and compliance with both internal policies and regulatory requirements.

Roles and Key Responsibilities:

- Coordinate and work closely with the operations and Gaza unit teams as well as relevant programming staff to ensure logistics services align with pipeline requirements. Identify challenges in supply chain management and provide actionable recommendations. Facilitate the movement of goods from to the warehouse to their final location at the Egyptian borders adhering to CRS and donor regulations, as well as international and local supply chain standards and ensure tracking tools are set in place and used by the logistics team.
- Collaborate with the procurement team to ensure timely and detailed purchase requisitions are received, including specifications, delivery schedules, and terms related to labeling, branding, and marking.

Coordinate and oversee activities related to the receipt, transport, distribution, and disposal of commodities. Collaborate with surveyors, customs and forwarding agents, transport officers, , and other stakeholders to ensure efficient operations. Maintain comprehensive files of all logistics documents. Ensure all activities and movements are documented accurately and prepare or review reports according to distribution requirements. In Fleet Management, the Logistics Officer leads the administration of the fleet, ensuring optimal utilization, regular maintenance, and strict adherence to safety regulations. This role involves overseeing vehicle assignments and scheduling to maximize resource efficiency, crucial in emergency response operations.
